



# What is FAFSA Simplification?

FAFSA Simplification is the result of a multiple legislative and federal regulatory changes intended to demystify and streamline the financial aid process for students and families.

# Major Changes for the 2024-25 Year

The FAFSA became available December 2023

The Expected Family Contribution (EFC) will be replaced with the Student Aid Index


Number in college no longer considered Parent who provides financial support is the contributing parent

Contributor must be invited to provide information on the FAFSA

No student housing information will be provided to the PSI

Students will receive a FAFSA Submission Summary (FSS) FAFSA will populate from a Direct Data Exchange with the IRS There will be multiple ways to determine a student's Pell Eligibility based on a payment formula

Pell will prorate in proportion with student's enrollment






# Dependent Student Log In



If the student selects "Start a New Form" from the FAFSA® landing page and they are not logged in to StudentAid.gov, they are taken to the "Log In" page to enter their login credentials. To access the FAFSA form, all students are required to have an FSA ID (account username and password). If the student doesn't have an FSA ID, they can select "Create an Account."

# Dependent Student Roles

After logging in, the student can select the applicable role to fill out the FAFSA® form:
"Student," or "Parent." The student selects "Student."



# Federal Aid Eligibility Requirements

- Demonstrate financial need for need-based federal student aid programs
- U.S. citizen or an eligible noncitizen
- Have a valid Social Security number (with the exception of students from the Republic of the Marshall Islands, Federated States of Micronesia, or the Republic of Palau)
- Be enrolled or accepted for enrollment as a regular student in an eligible degree or certificate program

- Maintain satisfactory academic progress in college or career school
- Provide consent and approval to have federal tax information transferred directly into 2024–25 Free Application for Federal Student Aid (FAFSA®) form, if applying for aid for July 1, 2024, to June 30, 2025;
- Sign the certification statement on the FAFSA form stating that student is not in default on a federal student loan, does not owe money on a federal student grant, and will only use federal student aid for educational purposes; and
- Qualified to obtain a college or career school education.

# Citizen/ Eligible Non-Citizen Status

- U.S. Citizen (By Birth or Naturalized)
- U.S. Permanent Resident
- "Refugee"
- "Asylum Granted"
- "Cuban-Haitian Entrant (Status Pending)"
- "Conditional Entrant" (valid only if issued before April 1, 1980)
- Victims of human trafficking, T-visa (T-2, T-3, or T-4, etc.) holder
- "Parolee" (must be paroled into the United States for at least one year and must be able to provide evidence from the USCIS that the person is in the United States for other than a temporary purpose and that the intention is to become a U.S. citizen or permanent resident.)

#### Contributors to the FAFSA® Form



#### **Parents or Spouses**

Your answers on the FAFSA form will determine if any contributors need to be identified. These contributors will complete their own sections of the form and are asked to provide personal and financial information, but will not become financially responsible for your education.



#### → How to Invite

Contributors will need to log in with their own FSA ID to provide their information. To invite a contributor to your FAFSA form, you'll need to provide their name, date of birth, Social Security number, and email address.

Information or Documents You May Need A

You might need the following information or documents as you fill out the FAFSA form:

- Tax returns
- Records of child support received
- Current balances of cash, savings, and checking accounts
- Net worth of investments, businesses, and farms


# Parents are Divorced or Separated

- Parents may be biological or adoptive
- Contributing Parent provides most financial support
- If the Contributing Parent is remarried step-parent information is required



## Dependent Student Invites Parents to FAFSA® Form

▶The student is asked to enter personal information about their parents in order to send them an invite to their FAFSA® form. In this scenario, the student invites one parent.



# Granting Consent

- All contributors must grant consent for the FAFSA to be submitted and analyzed
- Consent allows contributor to retrieve and disclose federal tax information
- Consent must be granted by all contributors for the student to be eligible for federal student aid
- If consent is not granted to will not be eligible to receive an SAI.













#### Provide Consent or Be Ineligible for Federal Student Aid

#### Summary

Your consent is needed to retrieve and disclose federal tax information (FTI). With your consent, we can obtain tax return information automatically from the IRS to help you complete the FAFSA® form. If you don't provide consent, you will not be eligible for federal student aid. including grants and loans. You must provide consent even if you didn't file a U.S. federal tax return or any tax return at all.

- → Get your 2022 tax return information for the 2024-25 FAFSA form.
- -> Tax return information is required to complete the FAFSA form.
- > FTI is used to determine your eligibility for federal student aid.

Under penalty of law, I certify that I am the individual associated with the FSA ID log-in credentials used to access the FAFSA form to provide the necessary approval and consent for the disclosure and use of my federal tax information (FTI) from the U.S. Department of the Treasury. By accepting below, I approve and consent to:

- . The U.S. Department of Education to disclose my Social Security number, last name, and date of birth to the U.S. Department of the Treasury in order to obtain my FTI only for the purpose of determining the eligibility for, and the amount of, federal student aid for myself or of others for which I participated and shared my FTI by a program authorized under subpart 1 of Part A. Part C, or Part D of Title IV of the Higher Education Act of 1965, as amended.
- . The use of my FTI by U.S. Department of Education officials and contractors (as defined in 26 U.S.C. § 6103(1)(13)), only for the purpose of determining the eligibility for, and amount of, federal student aid for myself or of others for which I participated and shared my FTI by a program authorized under Title IV of the Higher Education Act of 1965, as amended.
- . The U.S. Department of Education to redisclose my FTI received from the U.S. Department of the Treasury, pursuant to 26 U.S.C 6103(I)(13)(D)(iii), which includes:
  - o institutions of higher education participating in the federal student aid programs authorized under the Higher Education Act of 1965, as amended:
  - o state higher education agencies; and
  - o scholarship organizations designated prior to Dec. 19, 2019, by the Secretary of Education.
- . The use of my FTI for the application, award, and administration of student aid awarded by the federal government, institutions of higher education, state higher education agencies, and designated scholarship organizations.
- . The redisclosure of my FTI to any future 2024-25 FAFSA forms for which I elect to participate (e.g., if I elect to participate in my child's FAFSA form or to complete my own FAFSA form after participating in another FAFSA form). My FTI will be redisclosed to these additional applications upon my affirmation to participate. I understand that I may decline an invitation to participate, which will prevent the transfer of my FTI to that FAFSA form.

By approving and consenting, I further understand: . My approval and consent are a condition of my eligibility or of others for which I have participated and shared my FTI for federal student aid, even if I did not file a U.S. federal tax FTI received from the U.S. Department of Treasury will supersede any manually entered financial or income information on the FAFSA form. . The U.S. Department of Education may request updated tax information from the U.S. Department of Treasury once consent is provided. If FTI has changed (e.g., amended tax return filed with revised FTI), then eligibility for and amounts of federal, state, and institutional financial aid may change. . If I do not approve and consent to the disclosure of my FTI, the U.S. Department of Education will be unable to calculate my eligibility for federal student aid or the eligibility of others who have requested that I share my FTI on their FAFSA form. . I am permitted to revoke my approval and consent for the disclosure and use of my FTI, as outlined herein, at StudentAid.gov. However, by revoking such approval and consent, neither I nor other applicants for which I participated and shared my FTI will be eligible for future federal student aid and/ or other financial aid program that used FTI to make determinations for eligibility of aid awarded by an institution of higher education, state higher education agency, or other designated scholarship organization. #### Things You Should Know



#### View Your FAFSA® Submission Summary

Once your application is complete and submitted, you can view your FAFSA Submission Summary, a summary of the information you provided on your FAFSA form. You'll be able to access the FAFSA Submission Summary one to three days after you submit your application by logging back in with your account username and password (FSA ID).

There are times when the information requested on the FAFSA does not reflect a student's situation. The school the student attends has the ability to utilize professional judgment to adjust the student's file accordingly.

# Unusual Circumstances

Unusual Circumstances refer to the conditions that justify an aid administrator making an adjustment to a student's dependency status based on a unique circumstance.

#### Initial Eligibility Requirements: (As determined by the Florida Department of Education)

- 1. Submit the Florida Financial Aid Application (FFAA) no later than August 31 after high school graduation.
- 2. Graduate from a Florida high school with a standard high school diploma or its equivalent.
- 3. Complete the 16 college-preparatory courses required for admission to a state university.
- 4. Achieve the required weighted GPA in the 16 college-preparatory courses per the chart below.
- Achieve the required composite ACT\* score, Overall Score on the Classic Learning Test (CLT), or combined SAT\* score no later than August 31 of the student's graduation year (or through January 31 for mid-year graduates), per the chart below.
- Complete the required number of volunteer service hours, paid work hours, or 100 total combined hours per the chart below.

# Current Bright Futures Requirements

#### Initial Eligibility Requirements: (As determined by the Florida Department of Education.)

- 1. Submit the Florida Financial Aid Application (FFAA) no later than August 31 after high school graduation.
- 2. Graduate with a standard Florida high school diploma or its equivalent.
- 3. Achieve the required weighted 3.0 GPA in the non-elective high school courses.
- 4. Complete at least 3 full credits in a single Career and Technical Education program.
- 5. Achieve the required minimum 3.5 unweighted GPA in the single Career and Technical Education program.
- Complete at least 30 volunteer service hours, 100 paid work hours, or a combination that equals a minimum of 100 total hours.
- 7. Achieve the required minimum scores on one of the college entrance exams per the chart below no later than August 31 of the year the student graduates from high school.
